Drop off hours 9:00 AM TO 3:00 PM Saturday May 11th, 2024

Drop Off Location For Hazardous Waste Only at 680 Swan Falls Rd.

There will NOT be a curbside pick-up on this day. The curbside pick-up is APRIL 29TH -May 10th (See next page for info)

The following items will NOT beaccepted at dropsite:

General Waste, Scrap Metal, Tree Limbs, Brush, or Bulky Items (These are curbside items, See next page for curbside info)

The following items WILL be accepted at drop site:

- ✓ Used Oil Filters
- ✓ Used Motor Oil--Must be in containers, 5-gallon size or smaller.
- ✓ Car and Household Batteries
- ✓ Cleaners (acid & lye)
- ✓ Solvents
- ✓ Latex Paint--Must be in containers, 5-gallon size or smaller.
- ✓ Oil Base Paint--Limited to 5 gallons or less per household.
- ✓ Anti-freeze
- ✓ Television & Computer Monitors
- ✓ Turpentine
- ✓ Pesticides, Herbicides, and Fertilizers
- Residential refrigerators, freezers and air conditioners containing freon.
 - 2 per household: \$10 each unit (No Dealers or Commercial Units)
- √ Tires--can be disposed of for a fee* (Tire disposal limited to 10 per household)
 - Passenger/Motorcycle/ATV Tires: \$3.00 each off rim / \$5.00 on rim
 - Light Truck Tires: \$4.00 off rim / \$6.00 on rim
 - Large Truck Tires: \$10.00 off rim / \$18.00 on rim
 - Farm Tires: Negotiated
 - Larger or Odd Tires: By bid or negotiated.

All City of Kuna residents dropping off at this event will be required to present proof of residency.

Accepted forms of payment: Cash or Check ONLY







Kuna Curbside Clean Up 2024

The event will be held over a 2-week period leading up to the Hazardous Waste Drop Site Event held on Saturday May 11th. Our customers within the city limits will be allowed to place large bulky items and excess trash on the curb at no extra charge on your regular service day. Your pickup week will be determined by the color-coded map that is attached. You can also refer to the map on our Facebook page or J&M Website. The yellow areas will be serviced on the 1st week April 29th through May 3rd and the red areas will be serviced on the 2nd week May 6th through May 10th. Items placed at curbside need to be no more than a regular pickup truck bed amount. All hazardous waste (T.V.s, oil, antifreeze, paints, pesticides, car tires, batteries, and any items that contain freon) will need to be brought to our Drop site event on Saturday May 11th, following the 2 weeks of curbside pick-up. We will NOT pick up any hazardous waste items curbside.

Items NOT accepted curbside or at drop off site are dirt, rock, concrete, sod, or large amounts of wood.

All items that are not large bulky items need to be bundled, boxed, bagged or in a container no larger than 35gallons.

Our Hazardous Waste drop site event will be held on Saturday May 11th at the end of the 2 weeks of curbside pick-up. Residents will be able to bring their Household Hazardous Waste items to this event. all tires and refrigeration units will be taken at a discounted Fee. We will not be taking any general waste or scrap metal at this event only accepted hazardous waste.

All City of Kuna residents dropping off at the Hazardous waste event will be required to present a City of Kuna Water bill. Renters can get a copy of the bill from their landlords. If you are not able to get a copy of your water bill you must provide another solid proof of residency. We will not be accepting any loads that do not have proof of residency with them.
